(Code 40-8-76)*




Effective July 1, 2011

Children under age 8 must be properly secured in an approved car seat or booster seat while riding in passenger automobiles, vans and pickup trucks.

CAR & BOOSTER SEATS MUST

- Be in the rear seat.
- Be appropriate for child's weight & height.
- Meet U.S. Federal standards.
- Be installed according to manufacturer's instructions.

Having Problems Installing your Child Safety Seat?

Have you read the child safety seat manual but are still confused about how to install it correctly and safely?

The Dunwoody Police Department can help you install your child safety seat.

Please bring:

- **Child safety seat.**
- **Child (if possible).**
- **Child safety seat manual.**
- **Vehicle in which child safety seat will be installed.**
- **Vehicle manual.**

IMPORTANT QUESTIONS

- Is the seat belt routed through the correct path of the child safety seat?
- Are you using the LATCH system in your vehicle? Are you using it correctly?
- Is the retainer clip at your child’s armpits?
- Is the crotch strap at its shortest position?
- Are the shoulder belts in proper slots at or BELOW shoulder for rear facing and at or ABOVE shoulder for forward facing?
- Do you know the history of your child safety seat?
- Are there toys or a mirror near your child?
- Is your child in the correct child safety seat for his/her height, weight and age?

INFORMATION AND STATISTICS

All children **under the age of 13** should ride in the back seat.

Child safety seats can reduce fatal injury by 71% for infants and by 54% for toddlers, ages 1-4.

Don’t know which child safety seat to choose for your child?

ALWAYS READ LABELS

Infant Seat

Birth to 22-35 lbs

Rear Facing only

- **NEVER** in front of active airbag.
- Straps **SNUG**.
- Retainer clip at armpit level.



Convertible Seat

Rear Facing 4-40 lbs

Forward facing 20-65 lbs

Rear Facing or Forward Facing

- Use straps at or above shoulders.
- Retainer clip at armpit level.



Combination Seat

From 20-120 lbs

Forward facing only

- Straps at or above shoulders.
- Mid-Point of back of head is not above top of seat shell.
- Back is reinforced at each set of slots.



Belt Positioning

Booster Seat

From 40-100 lbs

Forward facing only

- No harnesses.
- Use with vehicle lap/shoulder belt, **NEVER** lap belt only.
- Lap/Shoulder belt should lie across child's shoulder and chest not neck
- Lap/Shoulder belt should lie across top of child's thighs.
