2. The second reference to subsection "Sec. 20-69(e)" should be corrected to read "Sec. 20-69(f)";
3. The phrase "graffiti elements" in Sec. 20-69(d) should be changed to read "unauthorized elements";
4. Sec. 20-69(e) should read: "No installations of public art shall be permitted in the public right-of-way, with the exception of installations along the Dunwoody Trailway, unless permitted by the community development director, economic development director, and public works director";
5. Sec. 20-69(g) should be inserted and read: "Exceptions to Sec. 20-69(a) and 20-69(b) may be authorized by CREATE Dunwoody and City Council or City Council's designee."
