

Request for Qualifications (RFQ 24-07)
Dunwoody Parks and Recreation Women's History Month Murals
Brook Run Skate Park, Dunwoody GA

Project Summary

The Dunwoody Parks and Recreation Department is issuing a "Request for Qualifications" (RFQ 24-07) for the design of large-scale outdoor murals celebrating Women's History Month. The selected artist(s) will be expected to work in conjunction with the Dunwoody Art Commission in the approval process to implement the design. Expected completion date is February 24, 2025.

Eligibility

This request is open to all artists, working in any medium.

Project Budget

Varies per mural, dependent on artist resume, inclusive of all artist fees, materials, and installation. Total exhibit budget not to exceed \$15,000.

Deadline for Submission

December 20, 2024

Selection Process

Selection will be conducted in two stages:

1. An initial submission of proposed artist fees will be reviewed by Dunwoody Parks and Recreation
2. The Dunwoody Art Commission will review proposed design(s)

RFQ Submission Guidelines:

The following components must be submitted with each application for it to be deemed complete and eligible for review by Dunwoody Parks and Recreation and the Dunwoody Art Commission:

1. A current resume including references
2. Proposed design(s) for mural(s)
3. Proposed fee
4. Artists statement that addresses interest in project

Project Specifications:

From March 1 to March 31, 2025, 8'L by 4'H murals will be displayed along the perimeter fence of the Brook Run Skate Park. Murals will be displayed outdoors for the duration of the exhibit. It will be the artists' responsibility to ensure materials used are suitable for the outdoors for the length of exhibit. Murals must be designed to be displayed horizontally. One plywood sheet and one can of primer will be provided to each artist. The artist is responsible for picking up materials and delivering the completed mural to the Brook Run Skate Park. Dunwoody Parks and Recreation will be responsible for hanging murals along fence line. Examples of previous murals can be found in **Exhibit A**.

Location Description:

Located within Brook Run Park at 4770 N. Peachtree Rd., Brook Run Skate Park is the largest skate park in the metro Atlanta area, consisting of a variety of skate terrain for all skill levels. The park was designed to accommodate entry-level skaters, as well as, challenge more advanced “street skaters” looking to test themselves on elements they might encounter throughout most public locations. The 27,000 sq. ft. facility is a “flow” type of park and is fully lighted. The Skate Park is open year-round, seven days a week from 7:00 a.m. – 9:00 p.m. (Sunday through Thursday) and 7:00 a.m. – 10:00 p.m. (Friday and Saturday).

Selection Process and Schedule

Together, Dunwoody Parks and Recreation and the Dunwoody Art Commission will review proposals. Project timeline will be scheduled as follows:

- December 20, 2024: Deadline for receipt of proposals
- January 7, 2025: Review proposals during Dunwoody Art Commission meeting; Artist(s) selected
- February 24, 2025: Murals delivered to Dunwoody Parks and Recreation
- March 1, 2025: Installation complete
